- (a) in an individual concentration of $\geq 1\%$ by weight for non-gaseous mixtures and $\geq 0.2\%$ by volume for gaseous mixtures at least one substance posing human health or environmental hazards; or

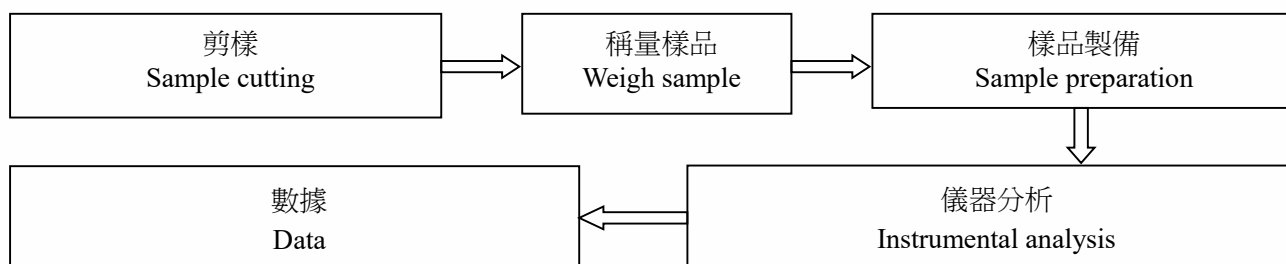

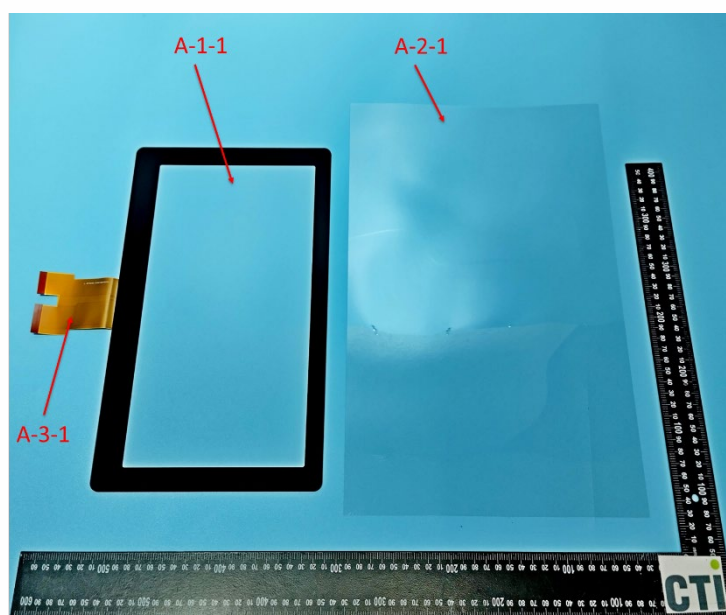
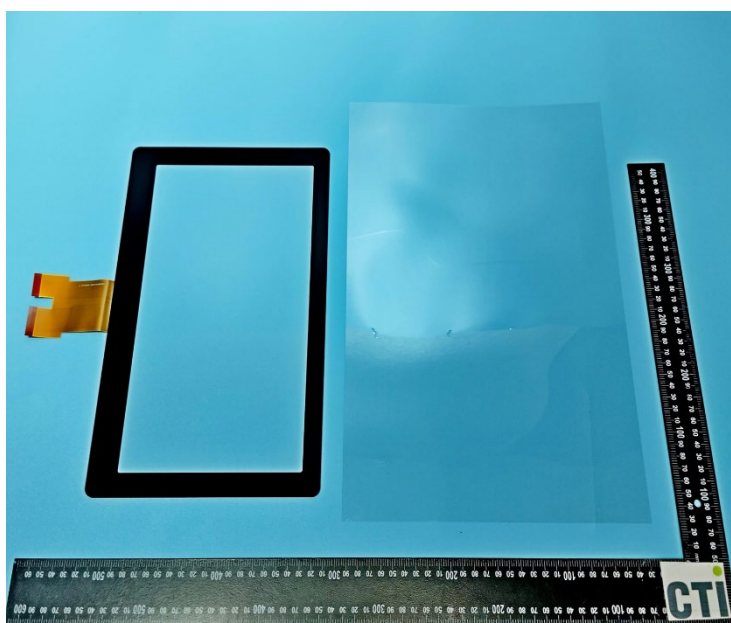
